**General**

- 2.1. The event shall be organized in conformity with the prescriptions of the FIA International Sporting Code, the National Sporting Code, the CEZ Slalom Regulation, the Croatian Slalom Regulation and the prescriptions of these Supplementary Regulations.

<b>Article 3.</b>

**Course**

- 3.1. This event will take place on the improvised track in Kutina, Mate Lovraka street, Antuna Gustava Matoša street and King Tomislava square.
- 3.2. Base of the course is asphalt and the zone for racing will be marked with cones.
- 3.3. Length of the track is 1025 m.

**Eligible vehicles**

- 4.1. All vehicles that participate on event will be divided as follows:

**CEZ trophy**

- Division 1: Group N (incl. R1) and Group A (incl. R2 and R3, WRC & KITC), S2000, SP (all together)
- Division 2: Group E1\*, E2-SH\*, GT
- Division 3: Group Standard Production Cars \*\* and Group Improved Standard Production Cars \*\*\* (all together)

\* = according to the national regulation (each car must be accompanied by the confirmation of the home ASN that the car corresponds with the national regulation).

\*\* = every car must also correspond to the technical regulations for Standard Production Cars of FIA-CEZ.

\*\*\* = every car must correspond to the technical regulations for improved Standard Production Cars of FIA-CEZ

**Croatian autoslalom championship:****Group I** serial vehicles

- Class 1- up to 1200 ccm
- Class 2- from 1200 to 1600 ccm
- Class 3- over 1600 ccm

**Group II** sprint vehicles

- Class 4- up to 1200 ccm
- Class 5- from 1200 to 1600 ccm
- Class 6- over 1600 ccm

**Group III** sporting vehicles

- Class 7- group E1

- 4.2. All other has to be in conformity with the prescriptions of the FIA International Sporting Code, the National Sporting Code, the CEZ Slalom Regulation, the Croatian Slalom Regulation and the prescriptions of these Supplementary Regulations.
- 4.3. Starting numbers will be ensured by organizer only for drivers that are not CCKF license holders. CCKF license holder have to ensure their own starting numbers. Obligatory sticker of the organizer will be published by bulletin and ensured by the organizer at the admittance.

**Article 5.**

**Gear shift**

- 5.1. All vehicles have to be equipped with an electric starter and a gear box with a rear gear.

**Article 6.**

**Competitors, drivers and equipment**

- 6.1. Any driver/competitor holding a license valid for 2017 registered for CCKF, or any CEZ country, and has insurance policy and valid medical confirmation not older than 6 months, can participate on this event.
- 6.2. Max 2 divers can compete with one vehicle.
- 6.3. It is obligatory for the driver to have driver gloves, racing helmet and safety belt during race.
- 6.4. It is mandatory that driver has clothes with long sleeves and long pants on.
- 6.5. It is recommended for the driver to wear a fire resistant overall (it does not have to be homologated)
- 6.6. The driver has to close window on their side during the race.

**Article 7.**

**Entries**

- 7.1. Entries for the drivers outside of Croatia, will be made by the FIA CEZ form that is enclosed to this Regulations. CCKF drivers make their entry by national regulation app A09 article 10.
- 7.1.1. About eventual acceptance of the payment of entry fee after dead line, will be discussed by the Stewards but only after paying a double fee.

**Article 8.**

**Entry fee**

- 8.1. Drivers from Croatia have to pay entry fee on the account:

- 8.2. **Confirmation of the payment has to be sent to the organizer.**

- 8.3. Entry fee is 300 HRK/ 40 € + insurance.

- 8.4. Participation on the event will be allowed only if the entry fee is payed. Foreign drivers can pay fee on the admittance.

**DRIVER WHO'S ENTRY FEE WILL NOT BE ON THE ORGANIZERS ACCOUNT BY 18.4.2017, WILL NOT BE ON THE LIST OF ENTRIES.**

**Article 9.**

**Responsibility and insurance**

- 9.1.1. Each driver/competitor drives on its own responsibility. The organizer does not accept any responsibility towards the driver for injuring the persons or damaging property of the drivers, competitors, mechanics, and other parties. Each competitor and driver is obliged to make it's own insurance at administrative checks.
- 9.2. Organizer will have insurance for the spectators and officials.

**Article 10.**

**Running of the event**

- 10.1. Admittance and Administrative checking  
Admittance and Administrative checking and scrutineering will take place on Sunday 23.4.2017. at Elementary school "Vladimir Vidrić", Školska street 2 in Kutina from 08,00 – 9,00. This is also position of the HQ.
- 10.2. At the scrutineering it is obligatory to have vehicles documentation and homologation (if required by the regulations).
- 10.3. Practice and race  
Practice and race will be held according the program of this event. One practice will take place, and it is not obligatory. There will be 3 races that will be timed.
- 10.4. Starting procedure  
The start will take place with the vehicle stationary and the engine running and in intervals of app. 20 sec with traffic light. The finish shall be a flying finish; however, the vehicle shall be brought back to the paddock in much lower speed.

**Article 11.**

**Classification**

- 11.1. The race will be run in three heats. For the total classification the addition of the two fastest heats (including possible penalties) will be taken.
- 11.2. Penalties will be according to the CCKF App A09 for season 2017.
- 11.2. The following classifications shall be drawn up:
- 2017 CEZ slalom trophy
  - 2017 Croatian autoslalom championship
  - 2017 Northern CCKF league championship

**Article 12.**

- 12.1. The organizer will at the end of the event award the drivers as follows:

**Prize giving**

- 13.1. Participating and the Prize giving is moral obligation for all participants of the event.
- 13.2. Prize giving will take place on Sunday 23.4.2017., at 18.00 in front of the HQ, if not decided differently by the Stewards.

**Other**

- 14.1. Because of the safety reason in the Paddock it **is forbidden to use open fire, gas or electric cookers, barbecues etc.** Otherwise, it will be charged by fine by the organizer.
- 14.2. Organizer will ensure catering and drink by popular prizes for participants.
- 14.3. The organizer reserves the right to add conditions to this Supplementary regulations, to postpone or cancel the event in the cause of Force Major.

<b>Article 15.</b>

By participating in the event, each competitor/driver officially waives all rights to compensation arising in connection with accidents which may befall competitors/drivers or their assistants during practice or the race, or during trips from the parking areas to the track and back. This waiver shall apply vis-à-vis the FIA, the ASN, the organizer, the various officials, and other competitors/drivers or their assistants.

**ECOLOGY**

Competitors / drivers are required to invest all possible efforts to protect the area performing competition of pollution. Special care should be given to pollution motor oil, brake oil and other petroleum products. During the event, where possible, try to use biodegradable materials for disposable or materials suitable for recycling.

**Mandatory use of the shims under the vehicle of the minimum size of 3 x 4 m, and the quality of pads should be such that it does not leak oil and motor fuel.**

Backing from the front of the right (looking from the front) must contain a **starting number, minimum size A4, which ensures the driver.**
